# I. Assignments and details for judge volunteers and courtroom liaisons

Thank you again for volunteering to serve as a judge for the 2024 National High School Mock Trial Championship ("NHSMTC") or as a courtroom liaison for the 2024 NHSMTC. We appreciate your willingness to contribute your time and talents to this program. If you are a judge or attorney in Delaware, you are eligible for up to three hours of CLE credit per day of volunteering. Please just complete Form 8B-2, which is in your folder, and leave it on your seat after check-in.

## A. Assignments

Attached to this memorandum and email is a chart of judge registration assignments and courtroom liaison assignments. Please note that you will be assigned to all rounds in which you volunteered. ## B. Place

All rounds will take place Friday and Saturday, May 3 and 4, 2024 at the Leonard L. Williams Justice Center. The Justice Center is located at 500 N. King Street, Wilmington, Delaware 19801. Please report for your assigned round(s) in the Jury Assembly Room on the first floor. When coming through security, there will be a dedicated line for judges and courtroom liaisons.

## D. Reporting Times for Championship Round

If you have been asked to judge the Championship Round on Saturday afternoon, please arrive at the Courthouse and proceed to jury services at 4:00 pm EDT. The round will begin as close to 5:00 pm EDT as possible. The round will be held in courtroom 7E. The round will also be livestreamed to the Dravo Auditorium at the Chase Center on the Riverfront.

## E. Awards Ceremony

#### II. Orientation and CLE credit

When you check in for your assigned round, you will be provided with an orientation packet containing information for the competition. This will include a Delaware CLE form. If you are from a jurisdiction that also provides CLE credit for mock trial (note that PA does not) please email Daniel Attaway and we will work to get you proof of attendance for you to submit.

All presiding and scoring judge volunteers must attend orientation for each round to which they are assigned in order to receive courtroom assignments, complete CLE forms, and to address issues that may arise from prior rounds.

You will not need to return to the Jury Assembly Room to sign out.

#### III. The Justice Center

The Justice Center allows individuals to bring in personal electronic devices, but you must comply with Administrative Order 2024-01.

There will be parking available in the Courthouse garage both Friday (at the usual cost – hourly, or \$11 for the day) and Saturday (at a reduced cost - \$3 for the day).

Attached is the Bench Brief for this year's Competition. Please do not share this document with anyone except another mock trial volunteer judge. **This document will not be included in your orientation packet**. The entire case is attached to this email.

## C. <u>Conflicts</u>

Please let us know as soon as possible if you have any conflicts with scoring teams in the competition. For reference, a "conflict" for purposes of the Competition, means that a member of your immediate or close family (or someone intimately associated with a member of your immediate or close family) is a participant in the competition or coaches a school in the

competition, you have been involved in preparing a team in the competition, or you recognize the team as coming from your state.
